### **Public comment**- 5 min please. 2 new Application Proposals

1. Garret Stannard, Jazz festival updated app.

Livingston Jazz Festival, 9 events, involving radio stations, 12 schools, Guest (Jazz Trio) coming in from LA to perform Friday evening and staying in Livingston, two universities playing the next day, 12 rooms for guest artists and bands (25 rooms) but can't track how many coming in and staying for event itself. The 25 rooms could be donated but the festival has the means to pay for them as well. The schools themselves have about 30-50 students per school. Comfortably 500 people will be involved in event (guests, participants, locals). Hotels can track by having a promo code. Eric would propose \$3000 if Garret would put out a survey to get some data for next year.

Kathleen motions to contribute \$4000, Eric seconds. Discussion: Tanya prefers \$3500 but would also be comfortable with \$4000. Meghan is excited about the future of this event and accepts the \$4000 motion. Kathleen amends motion to provide \$3500 upfront and \$500 when Garret comes back to the board with the data from the event. Meghan seconds. Discussion: none. All in favor, none opposed.

### 2.Tracy Gubler, Blitzkrug Athletic Club

Nonprofit club bringing in kids from 3 and up. This is a youth wrestling tournament. Facility fee is \$1900. Will have to do clean up and have no damage. 250 kids will be participating with 200+ will be coming from out of town. All clubs, is not a school event so no buses. Two day event. Is asking \$3200 for awards as the metals are a big deal to the kids so try to create something special. Eric makes a motion to grant request for \$3200. Kathleen seconds. Discussion: Kathleen suggests TBID sponsor all awards. All agreed. Kathleen amends the motion to use the grant money specifically for the awards. Eric seconds. Discussion: As far as rooms they will just book on their own. Do we want to do blocks of rooms? Agreed not to to keep an even playing field. But pushing to book direct would be preferred. All in favor, none opposed.
